# Presentation by Stroock & Stroock & Lavan LLP on Blockchain Technology and the Financial System: Legal and Regulatory Issues

### Annex A to the 1998 Foreign Exchange and Currency Option Definitions

FRBNY Senior Vice President and Assistant General Counsel Michael Nelson informed the group that the Foreign Exchange Committee ("FXC") is moving toward discontinuing its role as a Sponsoring Organization of Annex A to the 1998 Foreign Exchange and Currency Option Definitions.

### **Update on Global FX Code**

The group was briefed by Foreign Exchange Committee ("FXC") Secretary Christina Getz and FRBNY Staff Attorney Benjamin Snodgrass on the status of the development of the Global FX Code. Ms. Getz informed the group about the anticipated dates for the fatal flaw draft release and comment period. Ms. Getz stated that parts of the Code are expected to be published at the end of May. Mr. Snodgrass, who is working with Ms. Getz on the Code, provided the group with an overview of the comments received on the latest draft that were discussed at the FX Working Group meeting held in Sydney, Australia, on March 2-3, 2016. The group raised and discussed questions regarding compliance with the Code and the types of products covered by the Code.
