# **Special Election of Class B Director** For Remaining Portion of Term Ending December 31, 2019

To: Group 2 Member Banks of the Second Federal Reserve District Subject: Election of Reserve Bank Directors

In accordance with Section 4 of the Federal Reserve Act, as amended, and the circular dated October 2, 2018, the Federal Reserve Bank of New York is conducting a special election to fill the vacancy in the office of a Class B director of this Bank for the remaining portion of the term ending December 31, 2019. There is shown on the following page the name of the candidate nominated for such office, and by whom nominated.

To each member bank classified in Group 2 on September 26, 2018, the following are being sent with this circular:

- (a) Ballot for use in voting for a Class B director.
- (b) Pink ballot envelope in which the ballot is to be sealed.
- (c) Certificate envelope bearing on its face the certificate in regard to the vote.
- (d) Addressed envelope in which the foregoing should be returned.

The ballot and the certificate on the certificate envelope must be executed by an officer who has been authorized to cast the vote. A list of the officers designated for this purpose by the member banks in Group 2 is contained herein, and was also contained in the circular dated October 2, 2018. In order that the ballot may be secret, the name of the bank and the name and title of the voting officer should not be written on the ballot, but should be written only on the certificate envelope.

- (1) The ballot should be marked.
- (2) The marked ballot should be placed in the pink ballot envelope and that envelope sealed.
- (3) The sealed pink ballot envelope should be placed within the certificate envelope, and the certificate envelope should be sealed and the certificate thereon executed.
- (4) The certificate envelope containing the sealed pink ballot envelope should be returned to me in the enclosed self-addressed envelope.

The law provides that the ballot shall be cast within 15 days after receipt of the list of candidates transmitted herewith. The polls will open at 10 a.m., Tuesday, November 6, 2018 and will close at 12 p.m. on Wednesday, November 21, 2018. To be counted as valid, the ballot must be received at or before 12 p.m. on November 21, 2018. Upon the closing of the polls, the ballot box will be opened, the votes counted and checked by tellers, and the results of the election announced. The candidates may, if they so desire, be present or represented on this occasion.
