

The Prooklyn FUND

The \$10 Million Brooklyn Fund was launched by Brooklyn Chamber of Commerce in May 2013, in partnership with the New York Business Development Corporation and the Brooklyn Chamber's NYC Business Solutions Center. In addition to having access to loans ranging from **6 percent** to **8 percent**, potential borrowers get help with their business plans and budgets and other technical assistance.





A LOAN PROGRAM FOCUSED ON HELPING BROOKLYN BUSINESSES GROW

The Brooklyn Fund is a loan fund to help Brooklyn-based small businesses — and especially those owned by immigrant or veteran entrepreneurs — grow and expand.

The loans can have a wide range of uses including purchasing new equipment, increasing inventory, hiring new workers, etc.

Loan Eligibility

To be eligible, a business must be:

- For profit
- Registered in the United States
- Owned by a permanent resident or citizen of the United States

Loan Terms

- Loan amounts will not be less than \$25,000 or more than \$350,000
- Variable terms, 5-10 years
- Application fees range from \$150 to \$1300
- Interest rates ranging from 6%–8%

All of the above should serve as a guideline for applicants.

How to Apply

- Applications must be submitted through the Brooklyn Chamber's NYC Business Solutions Center. Technical assistance managers are available to help businesses complete the application and related required documents.
